The APAL State Committee in Andhra Pradesh has taken a strong step to advocate for the rights of persons affected by leprosy. On 1st September 2025, nearly 1,000 persons affected by leprosy had their disability pensions suspended by the Government, causing severe difficulties for their daily livelihood.

In response, APAL's State Committee raised the issue with the Deputy Chief Minister of Andhra Pradesh, who responded positively, gave assurance to resolve the problem, and also discussed long-term solutions to safeguard the pensions of persons affected by leprosy.

This important advocacy activity was made possible through the efforts and contributions of Mr. Prakash Done, Mr. Sayulu, and Mr. Ramakrishna Reddy from the State Committee. APAL remains committed to ensuring that the dignity, rights, and social security of persons affected by leprosy are protected.

On 5th September 2025, the State Committee of APAL (Association of People Affected by Leprosy) – Chhattisgarh conducted an interactive visit to Beldar Para Leprosy Colony, Champa.

Ms. Syambhai, State Coordinator of APAL and her team engaged with residents affected by leprosy and their families to understand their current living conditions, social challenges, and immediate needs. Community members actively participated in discussions, sharing their difficulties related to housing, sanitation, livelihood opportunities, education, and healthcare access.

Through this interaction, APAL documented critical details about:

Housing status – many families continue to live in kutcha houses with limited government support.

Basic amenities – shortage of toilets, safe drinking water, and sanitation facilities.

Livelihood issues – lack of stable employment opportunities, with many residents dependent on daily wage labour.

Healthcare and education gaps – limited access to medical services and the need for better educational opportunities for children.

The visit provided valuable insights into the urgent requirements of the colony, especially in the areas of employment generation, proper housing, and essential services. APAL's Chhattisgarh Committee reaffirmed its commitment to advocate for these needs with concerned authorities and development partners to ensure dignity, equality, and improved quality of life for persons affected by leprosy and their families.

APAL's interaction visit to the leprosy colonies in Jharkhand

9th September 2025, APAL's State Committee in Jharkhand, led by Secretary Mr. Madhusudan, recently visited the Palatod Leprosy Colony at Baniyahir Bhaga, Dhanbad, and interacted with the residents. The survey revealed alarming issues—houses built decades ago are now in a dilapidated state, the drainage system is broken, and there is an acute drinking water crisis forcing families to walk long distances and even bring water from Panipat. Many families have also been left out of Pradhan Mantri Awas Yojana (PMAY) benefits, leaving them vulnerable and excluded from essential welfare schemes.

The findings highlight that families affected by leprosy in this colony continue to live under poverty, poor housing, unsafe conditions, and social neglect. Immediate attention is needed from the government and social organisations to provide proper housing, streetlights, safe water, and inclusion in welfare programs. Ensuring these basic rights is not just about development—it is about restoring dignity, equality, and justice to these marginalized families.

The interaction brought out critical issues such as poor living conditions, lack of infrastructure, and limited access to essential services.

Residents highlighted urgent needs, including better housing, proper roads, reliable water supply, healthcare facilities, and support for livelihood opportunities. The visit also shed light on the urgent requirement for government intervention and infrastructural development to ensure dignity and quality of life for persons affected by leprosy living in the colony.

APAL's State Committee assured the community that their voices will be taken forward and reinforced the need for strong government support to address these long-pending issues.

The seminar featured key experts, including Dr. (CA) Sanjay Patra (FCRA Expert), Sujata Samal (Compliance Expert), and Chandra Bhusan Mehta (Compliance Expert). The sessions provided valuable insights into the recent changes in FCRA rules, practical compliance strategies for NGOs, and guidance on avoiding mistakes that could affect smooth operations.

Through this participation, APAL enhanced its knowledge on FCRA compliance, ensuring that our organization remains aligned with the latest regulations to continue serving persons affected by leprosy with transparency, accountability, and efficiency.

The committee reaffirmed its commitment to ensuring dignity, equality, and mainstream inclusion for persons affected by leprosy, with a rights-based approach to overcome these challenges.

On 11th August 2025, APAL's State Committee in Odisha, along with Mr. Prabhakar Sahoo, Board Member of APAL, held an important advocacy meeting with the Chief Secretary of Odisha and the Revenue Secretary.


The discussions focused on the land rights, housing, livelihood, and healthcare issues faced by people affected by leprosy in Odisha. A 200-page memorandum with detailed concerns and recommendations was presented during the meeting by Prabhakar Sahoo and Jayant Pradhan.

As a result of these continued efforts, on 15th September 2025, the Revenue & Disaster Management Department, Government of Odisha, issued an official directive to all District Collectors regarding the grievance petition submitted by APAL's representatives.

The directive specifically addresses the grant of homestead land to the residents of 86 self-settled leprosy colonies across the State, instructing Collectors to take appropriate action as per law for speedy redressal of these grievances and to report back to the Department.

This is a major step forward in resolving the long-standing land rights issues of persons affected by leprosy in Odisha.

APAL and its State Committee in Odisha reaffirm their commitment to work for justice, dignity, and secure living conditions for our community.
